
DESCRIPTION

LIFEBOAT INSPECTION, DRILLS, OPERATION, AND MAINTENANCE TRAINING SERIES

SERIES DESCRIPTION

All personnel need to be familiar with everything from inspection and maintenance to launching, operating, and the recovery of lifeboats, so they can safely and confidently operate the lifeboats on their installation.

This three-course series will provide a general overview of lifeboat operations, and survival, and rescue practices. Also, students will get an in depth review of the weekly and quarterly inspection and maintenance process.

Course one, A Training Guide to Lifeboat Inspection, Maintenance, & Alternative Launch Requirements, will explain the basic procedures for inspecting and maintaining lifeboats, davits, winches, and hooks and will guide personnel through the weekly and quarterly inspection and maintenance process.

This program also provides guidance on how offshore companies can perform alternative launch drills, while proving that all performance tasks that are required while the lifeboat is in the water can be satisfactorily replicated while the lifeboat is stowed in the davit with the maintenance pendants attached.

In course two, **Lifeboat Muster, Drills, Launch, and Retrieval Best Practices**, students will be able to identify different types of lifeboats and davits, and determine their launching procedures. They will also understand the process of mustering, conducting drills, and preparing to launch in an emergency.

Finally, Lifeboat Survival Practices: Operation, Navigation, Seamanship, and **Rescue** was designed to instruct the student in all areas relevant to launching, operating, and recovery of lifeboats.

PASSENGER VAN SAFETY TRAINING

DESCRIPTION

A passenger van is one of the best ways to travel with a large group. And since passenger vans can carry multiple workers in one vehicle, they can help companies reduce transportation costs.

However, operating and driving these vans is different from driving a regular car or truck. And it's important to realize that there are some special risks associated with passenger vans, including decreased maneuverability, larger blind spots, and a much greater risk of tipping and rolling over than other vehicles.

In fact, the National Highway Traffic Safety Administration found that rollovers cause roughly 60 percent of crashes involving passenger vans. Preventing rollovers involving passenger vans requires your understanding of the factors that contribute to the risks.

This course prepares drivers to be especially diligent when inspecting, loading, and maneuvering passenger vans to ensure safe operation. Length: 11 minutes



STOP & ULTIMATE WORK AUTHORITY: A GUIDE TO AUTHORITY AND RESPONSIBILITY IN OFFSHORE OIL OPERATIONS


DESCRIPTION

Concepts such as stop work authority, ultimate work authority, and reporting unsafe conditions featured in this program are all part of a new advancement that is changing the oilfield industry. In recent years, the industry has adopted a systems approach to protect workers, the public, and the marine and land environment.

This approach is now mandated by the United States Safety and Environmental Management System regulation (SEMS). Compliance with SEMS is monitored by the Bureau of Safety and Environmental Enforcement (BSEE).

TOPICS INCLUDE:

- Stop Work Authority (SWA): This module demonstrates ability to halt an operation, or decline to begin one, when you believe that hazards are not fully controlled.
- Ultimate Work Authority (UWA): UWA is the power to determine the course of action in a time of danger or restart an operation that has been shut down, as well as the final responsibility for safe operations in all conditions. This section defines who has UWA under the SEMS regulation, how that process can be administered and how that affects personnel.
- **Reporting Unsafe Conditions:** This right to report unsafe working conditions is protected by federal law. This module explains what employee rights exist under SEMS and how reports can be filed.
- Employee Participation Plan (EPP): The EPP explains how the operator can involve all employees, and not just management, in implementing or changing the SEMS plan. In this module we explain how the regulation also requires that employees covered by the EPP have access to the sections of the SEMS plan that involve their job.

HYDROGEN SULFIDE SAFETY FOR THE OIL AND GAS INDUSTRY

DESCRIPTION

Hydrogen Sulfide (H2S) is a very serious hazard that requires rigorous training, periodic drills, pre-planning, and special work precautions. Any company personnel working in an area with a risk of dangerous H2S concentrations must receive appropriate training prior to beginning work operations.

This program will train oilfield employees and contractors to recognize when H2S is present in their work area and introduce the precautions necessary to work with H2S safely. This information will help fulfill the training requirements of API RP 49, ANSI Z390.1, Rail Road Commission of Texas Rule 36, and other international regulatory standards. **Length: 38 minutes**


